COURSE DESCRIPTION:

ACTG 121, Financial Accounting, CRN# 30009, 4 units, 10:10-2:00 Mon & Wed. Plus 1 lab hour per week by arrangement Explores what financial accounting is, why it is important, and how it is used by investors and creditors to make decisions. Covers the accounting information system and the recording and reporting of business transactions, the application of generally accepted accounting principles, the classified financial statements, and statement analysis. Includes issues relating to asset, liability, and equity valuation, revenue and expense recognition, cash flow, internal controls and ethics. Transfer credit: UC: CSU

You are expected to have <u>completed</u> the assignment before class. Homework will be checked for credit daily. Late homework will not be accepted. If you cannot come to class, send your work with another student or you may email to instructor. Late homework is not accepted for credit.
